2. I state that the S.R. Education Trust is now managing the S.R.P. School, Hebri, Karkala Taluk.

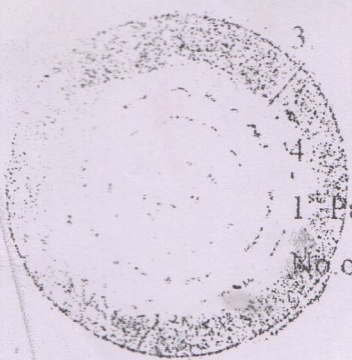
